# RESOLUTION

Condemning recent hate crimes committed against Asian  
American and Pacific Islanders.

Whereas following the spread of COVID–19 in 2020, there has been a dramatic increase in hate crimes and violence against Asian American and Pacific Islanders;

Whereas between March 19, 2020, and February 28, 2021, there have been 3,795 firsthand accounts of anti-Asian and Pacific Islander hate incidents and crimes from 47 States and the District of Columbia;

Whereas during this timeframe, race has been cited as the primary reason for discrimination, making up over 90 percent of incidents;

Whereas roughly 36 percent of Asian American and Pacific Islander businesses have been the top targets of discrimination incidents during this time period;

Whereas during this time, Asian American and Pacific Islander youth under 20 years old make up roughly 13 percent of victims;

Whereas during this time, Asian American and Pacific Islander elderly over 60 years old make up around 7 percent of victims;

Whereas, on January 28, 2021, Vicha Ratanapakdee died from injuries after being horrifically attacked in front of his home;

Whereas the Royal Thai Consulate-General in Los Angeles has warned Thai people in California to be on their guard following the killing of Vicha Ratanapakdee;

Whereas, on March 16, 2021, the following 8 people were murdered in 3 Asian-owned spas in Atlanta, Georgia: Xiaojie Tan, Daoyou Feng, Delaina Ashley Yaun Gonzalez, Paul Andre Michels, Soon Chung Park, Hyun Grant, Suncha Kim, and Yong Ae Yue;

Whereas 6 of the Americans killed in Atlanta on March 16th were Asian women – Xiaojie Tan, Daoyou Feng, Hyun Jung Grant, Suncha Kim, Soon Chung Park, and Yong Ae Yue;

Whereas 1 of the Americans killed in Atlanta on March 16, 2021, was a veteran who served in the United States Army – Paul Andre Michels; and

Whereas Asian American and Pacific Islanders have made significant contributions to American culture, own over 2,000,000 businesses in the United States, and are an es-

sentinal thread in the diverse fabric of American life: Now, therefore, be it

1       *Resolved*, That the Senate—

2           (1) affirms that the United States stands  
3       united in condemning and denouncing any and all  
4       anti-Asian and Pacific Islander sentiment in any  
5       form;

6           (2) condemns all manifestations or expressions  
7       of racism, and anti-Asian and Pacific Islander or  
8       ethnic intolerance;

9           (3) calls on the Committee on the Judiciary of  
10       the Senate to hold a hearing related to the surge in  
11       violence against Asian Americans and Pacific Island-  
12       ers;

13          (4) applauds the Department of Justice’s com-  
14       mitment to conduct a 30-day review of violence  
15       against Asian Americans and Pacific Islanders,  
16       which will seek to improve the Federal Government’s  
17       capacity to track and identify hate incidents, review  
18       civil enforcement authorities, and assess whether ad-  
19       ditional money is needed to support law enforce-  
20       ment’s response to the surge in violence; and

21          (5) calls on Federal law enforcement officials,  
22       working with State and local officials—

23                (A) to expeditiously and vigorously inves-  
24       tigate all reports of Asian American and Pacific

1           Islander hate crimes and threats in the United  
2           States;

3                   (B) to work to improve the reporting of  
4           Asian American and Pacific Islander hate  
5           crimes; and

6                   (C) to hold the perpetrators of those  
7           crimes, incidents, or threats accountable and  
8           bring the perpetrators to justice.
